We wish to notify the public & members of the business community about the Government support programmes that are administered by the Ministry for the purpose of industry development and the promotion of investment:

PURPOSE OF ASSISTANCE SCHEMES & ELIGIBILITY CRITERIA

<p>1. Duty Concession Scheme for the Tourism & Manufacturing Development Scheme</p>	<p>This support program is to encourage the development of the Tourism and Manufacturing industries through duty concessions on building and construction materials, furnishings and raw materials.</p> <p>Tourism Sector:</p> <ul style="list-style-type: none"> / In order to be eligible for this assistance, applicants must be a holder of a current business license and are VAGST registered. / Only include properly built and fully furnished motels, hotels & resorts providing short term tourist accommodations. / Consideration of assistance for New and Existing developments; <ul style="list-style-type: none"> • Existing operators: consideration will only be given if the expansion consists of no less than four (4) rooms or two (2) self-contained units; • New developments: consideration will be accorded to projects that intend to construct twelve (12) or more properly build rooms/units; • The new development project has a capital investment value of at least \$million tala. <p>Manufacturing Sector:</p> <ul style="list-style-type: none"> / In order to be eligible for this assistance, applicants must be a holder of a current business license and are VAGST registered. / Has a principal objective of manufacturing/processing for the domestic and overseas markets (exports)
<p>2. Code 121 Duty Exemption Scheme</p>	<p>This scheme provides duty exemption assistance on imported raw materials to further develop domestic businesses including: Commercial Poultry Farmers, Commercial Manufacturers of Agricultural Products, Commercial Handicraft Manufacturers and Commercial Elei Garment Manufacturers to effectively manufacture quality competitive products for both the domestic and international markets.</p> <ul style="list-style-type: none"> / For applicants to be eligible they must present a current business license and are VAGST registered. / Further, the applicant must also have an annual turnover equivalent to or more than SAT\$130,000.00 .

<p>3. Duty Concession Scheme for the Aviation Development Scheme</p>	<p>This scheme is one of the government's support programs aimed at further encouraging the development for Aviation Transport Development for small aircraft carriers.</p> <ul style="list-style-type: none"> ./ For applicants to become eligible, they must be beneficial to the economy of Samoa; ./ To be in the public interest. ./ The project is new to Samoa and must establish a new travel route or re-establish an old route no longer serviced by an air transport provider. ./ The applicant has no other aviation transport operations in any other country.


