## Cancellation of Foreign Investment Certificates (FIC) for Foreign Investment Enterprises (FIE)

Notice is hereby given for the following Foreign Investment Enterprises (FIEs) that have been issued a Foreign Investment Certificate (FIC) but have failed to notify the Ministry of the status of business operations within the stipulated timeframe will be subject to cancellation pursuant to Section 12[1] (e) & (f) of the Foreign Investment Act 2000 ('Act'). It states that "A certificate issued under this Act may be cancelled by the Chief Executive Officer if the business has not commenced operations within 2 years from the date the certificate was issued or the business has ceased operations in Samoa".

However, should the business wish to remain on the Register, Section 12[2] (b) of the Act requires 'the certificate holder to make written submission within ten (10) working days from the date of receipt of the notice' to the Ministry for reconsideration.

Failure to provide the Ministry with written submission within the above mentioned timeframe will result in the cancellation of the FIC and removal of the FIE from the Register.
