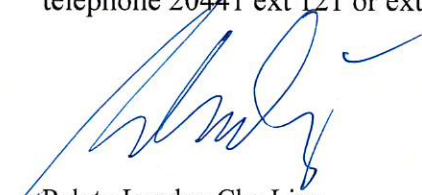
PUBLIC NOTICE
