The public is hereby advised that due to the increase in workplace non-compliance and the lingering threat of Covid-19, the Ministry of Commerce, Industry and Labour in line with the National Occupational Safety and Health Framework 2018, provides notice of key requirements of the Occupational Safety and Health Act 2002, and its Regulations 2017 to all Government Ministries, State Owned Enterprises and Private Sector in Samoa.

As a reminder to all our clients and stakeholders, the Ministry would like to reinforce the following key requirements that must be met:

- An overall policy around safety and health in the workplace including an emergency evacuation plan;
- Accident register and first aid kits provided to respond to accidents in the workplace;
- Strategically placed and serviced fire extinguisher(s) to respond to emergency situations;
- Provision of relevant Personal Protective Equipment (PPE) to carry out work safely;
- Relevant trainings for the job to ensure safety and health is observed and that these trainings are recorded; and
- To put in place necessary measures to ensure hazards and associated risks are managed especially in high risk and hazardous occupations.

- Ia faatino ni a'oa'oga talafeagai e feso'ota'i lelei ma galuega o lo'o faatino ina ia mautinoa le malupuipua o lona faatinoga; ma
