



Class 11: Coffee machines, electric; beverage cooling apparatus; electric beverage heaters; kettles, electric; water purification installations; coffee roasters; electric espresso machines; roasting apparatus; water dispensers; ice-cream making machines; footwarmers, electric or non-electric; radiators, electric; lamps; gas lamps; electric coffee machines; refrigerators; heaters for heating irons; heaters for baths; polymerisation installations; lights for vehicles; germicidal lamps for purifying air; nail lamps; hair dryers; watering installations, automatic.

Class 30: Coffee flavourings; coffee; coffee beverages with milk; coffee-based beverages; cocoa; tea-based beverages; sugar; bread; cereal-based snack food.

Class 35: Provision of an online marketplace for buyers and sellers of goods and services; sales promotion for others; administrative processing of purchase orders; advertising; presentation of goods on communication media, for retail purposes; commercial administration of the licensing of the goods and services of others; marketing; commercial information; personnel management consultancy; rental of vending machines.

Class 43: Canteen services; mobile food supply services; food and drink catering; accommodation bureau services [hotels, boarding houses]; restaurant services; bar services; snack-bar services; teahouse services; café services; cafeteria services.
