**REMINDER REGARDING THE MINIMUM WAGE INCREASE**

Owners of businesses, companies, organisations in the private sector and the State Owned Enterprises are kindly reminded to comply with the Minimum Wage increase of **\$4.00 per hour**, which was effective from 1<sup>st</sup> July 2024.

This increase is in accordance with the Cabinet Directive; FK (24)25 and is mandated under Section 32 of the Labour and Employment Relations Amendment Act 2023. The changes are implemented as follows;

- 1. \$4.00 per hour was effective on 1st July 2024; and***
- 2. \$4.84 per hour will be effective on 1st July 2025***
